Re-Organization Meeting

The Greene Township Board of Supervisors held their annual Re-Organization Meeting on Monday, January 5, 2026 at the Greene Township Municipal Building, 1145 Garver Lane, Chambersburg, PA 17202.

Present: Todd Burns, Travis Brookens, Shawn Corwell – Supervisors, Keityn Zullinger – Administrative Assistant

The meeting was called to order at 3:00 pm by current Chairman Todd Burns. The Chairman noted that the meeting was being recorded for accuracy purposes.

No public was present for public comment.

On a motion by Supervisor Brookens seconded by Supervisor Corwell with there being no other nominations, and by a vote of 3-0, Todd E. Burns was elected as Chairman of the Board of Supervisors for the year 2026.

On a motion by Supervisor Corwell, seconded by Chairman Burns, with there being no other nominations, and by a vote of 3-0, Travis L. Brookens was elected as Vice Chairman for the year 2026.

On a motion by Supervisor Brookens, seconded by Supervisor Corwell, with there being no other nominations, and by a vote of 3-0, Todd E. Burns was elected as Roadmaster/Director of Public Works for the year 2026.

On a motion by Chairman Burns, seconded by Supervisor Brookens, with there being no other nominations, and by a vote of 3-0, the remaining two (2) Board Members, Travis L. Brookens and Shawn M. Corwell, were elected as Assistant Roadmasters/Assistant Directors of Public Works for the year 2026.

On a motion by Supervisor Brookens, seconded by Chairman Burns, with there being no other nominations, and by a vote of 3-0, Shawn M. Corwell was elected as Office Administrator for the year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, with there being no other nominations, and by a vote of 3-0, the remaining two (2) Board Members, Todd E. Burns and Travis L. Brookens, were elected as Assistant Office Administrators for the year 2026.

On a motion by Supervisor Corwell, seconded by Chairman Burns, with there being no other nominations, and by a vote of 3-0, Travis L. Brookens was elected as Director of Parks and Recreation for the year 2026.

On a motion by Supervisor Brookens, seconded by Supervisor Corwell, with there being no other nominations, and by a vote of 3-0, the remaining two (2) Board Members, Todd E. Burns and Shawn M. Corwell, were elected as Assistant Directors of Parks and Recreation for the year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted that Township Supervisors, Todd E. Burns, Travis L. Brookens, and Shawn M. Corwell, be affirmed as working Township employees for the year 2026.

On a motion by Supervisor Brookens, seconded by Supervisor Corwell, and by a vote of 3-0, the Board unanimously voted to adopt Township **Resolution No. 1-2026** that in the event of a decision of the Board of Supervisors, the Chairman of the Board is authorized to execute, on behalf of the Board, such documentation as may be appropriate to evidence the decision of the Board.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to appoint Gina R. Griffith as Township Secretary for the year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to appoint Keityn M. Zullinger as Township Treasurer for the year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens and by a vote of 3-0, the Board unanimously voted to appoint Gina R. Griffith as Assistant Township Treasurer and Keityn M. Zullinger as Assistant Township Secretary for the year 2026; and the bond amount for each position to be set at \$2,000,000.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to set a bond amount of \$5,000 each for the following positions for year 2026: Roadmaster/Director of Public Works and Assistant Roadmasters/Assistant Directors of Public Works; Office Administrator/Assistant Office Administrator; and Director of Parks and Recreation and Assistant Directors of Parks and Recreation.

On a motion by Supervisor Brookens, seconded by Supervisor Corwell, and by a vote of 3-0, the Board unanimously voted to appoint Matt Runyon as Building code appeals board member for 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to appoint the following financial institutions to hold deposits and/or investments for the Township for the year 2026: Orrstown Bank, John Hancock, Wells Fargo Advisors, PLGIT, and F&M Trust.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to require a pledge of security from any financial institution holding deposits, investments, Certificates of Deposit, etc. for year 2026. (Includes: Orrstown Bank, John Hancock, Wells Fargo Advisors, PLGIT, and F&M Trust.)

On a motion by Supervisor Brookens, seconded by Supervisor Corwell, and by a vote of 3-0, the Board unanimously voted to appoint Kurt Williams (Salzmann-Hughes, PC) as Township Solicitor for the year 2026 and to appoint Tyler Beaston (Salzmann-Hughes, PC) as Solicitor to the Township Planning Commission for the year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to appoint Jonathan Piper (JWP Environmental) as Township Sewage Enforcement Officer for the year 2026 and Jacob Piper (JWP Environmental) as Assistant Township Sewage Enforcement Officer for the year 2026.

On a motion by Chairman Burns, seconded by Supervisor Corwell, and by a vote of 3-0, the Board unanimously voted to appoint the following engineering firms for year 2026: Martin & Martin, Inc., HRG (Herbert Rowland & Grubic), YSM (Yost Strodoski Mears), ECS Limited, Brehm-Lebo Engineering, Inc., Rettew Engineering, Dennis E. Black Engineering and RK&K (Rummel, Klepper & Kahl, LLP).

On a motion by Supervisor Brookens, seconded by Supervisor Corwell, and by a vote of 3-0, the Board unanimously voted to re-appoint William Green as representative to the Township Vacancy Board for year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to re-appoint Brooke Wenger to the Township Planning Commission, term to expire December 31, 2029.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to re-appoint Donald Kunkle to the Township Municipal Authority, term to expire December 31, 2030.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to adopt Township **Resolution No. 2-2026**, appointing Glenn Watson as a regular member to the Zoning Hearing Board, term to expire December 31, 2028.

On a motion Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to re-appoint SEK & Company as its independent auditing firm for year 2026.

On a motion by Supervisor Brookens, seconded by Chairman Burns, and by a vote of 3-0, the Board unanimously voted to appoint Shawn M. Corwell as the Township Emergency Management Coordinator and Andrew Melius as the Deputy Emergency Management Coordinators for year 2026.

On a motion by Supervisor Brookens, seconded by Supervisor Corwell, and by a vote of 3-0, the Board unanimously voted to adopt Township **Resolution No. 3-2026** to authorize the Township to procure items through qualified public procurement units.

On a motion by Supervisor Brookens, seconded by Chairman Burns, and by a vote of 3-0, the Board unanimously voted to adopt Township **Resolution No. 4-2026** to appoint Shawn M. Corwell as the *Designation of Agent* for the Township in the event of severe weather reimbursements from federal and/or state agency(ies) for the year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to adopt Township **Resolution No. 5-2026** establishing the 2026 fee schedule.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to designate the Supervisors Regular Meetings be held the second Tuesday of each month at 7:00 pm, Eastern Prevailing Time, and the fourth Tuesday of each month at Noon, Eastern Prevailing Time. All meetings will be held at the Greene Township Municipal Office Building, 1145 Garver Lane, Chambersburg, PA 17202. Work sessions will be advertised and held as needed.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to appoint Travis L. Brookens as the Township representative to the Letterkenny Army Depot Restoration Advisory Board with the remaining Board Members Shawn M. Corwell and Todd E. Burns serving as alternates for the year 2026.

On a motion by Supervisor Brookens, seconded by Chairman Burns, and by a vote of 3-0, the Board unanimously voted to appoint Shawn M. Corwell to the Regional Ambulance Committee with Andrew Melius serving as alternate for the year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to appoint Travis L. Brookens to serve as representative on the Council of Governments with the two remaining Board Members Todd E. Burns & Shawn M. Corwell serving as alternates for the year 2026.

On a motion by Supervisor Brookens, seconded by Supervisor Corwell, and by a vote of 3-0, the Board unanimously voted to appoint Shawn M. Corwell as representative to the Franklin County Emergency Services Alliance with the two remaining Board Members Todd E. Burns & Travis L. Brookens serving as alternates for the year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to appoint Todd E. Burns as representative to the Franklin County Tax Collection Committee with the two remaining Board Members Travis L. Brookens and Shawn M. Corwell serving as alternates for the year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to appoint Todd E. Burns as the Township's representative to the Franklin County Area Tax Bureau with Travis L. Brookens serving as alternate for the year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to approve equipment rental charges for the year 2026.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to adopt Township **Resolution No. 6-2026** authorizing the Township Treasurer to pay invoices due between meetings with either Chairman or Board member approval during the year 2026.

On a motion by Supervisor Brookens, seconded by Supervisor Corwell, and by a vote of 3-0, the Board unanimously voted to adopt Township **Resolution No. 7-2026** setting tax collector fees.

On a motion by Supervisor Corwell, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to authorize the Roadmaster/Director of Public Works, Assistant Roadmasters/Assistant Directors of Public Works, Office Administrator, Assistant Office Administrators, Director of Parks and Recreation, or Assistant Directors of Parks and Recreation, the maximum expenditure of \$5,000 without full Board approval during the year 2026.

On a motion by Chairman Burns, seconded by Supervisor Brookens, and by a vote of 3-0, the Board unanimously voted to certify Travis L. Brookens as the voting delegate and Shawn M. Corwell as the alternate voting delegate at the State Association Annual Conference to be held in Hershey, PA on April 19-22, 2026; Township staff was delegated to attend the conference with the current IRS mileage rate at the time of the conference to be given as travel reimbursement.

The Solicitor was not present for comment.

There being no further business before the Board for the 2026 Re-Organization Meeting, the Chairman adjourned the meeting at approximately 3:41 pm.
